Visitation Status:

Unfortunately, we had a staff member test positive. This staff member does not work directly with residents and is at home on quarantine. As such, visitations, beauty shop services, group activities and communal dining are temporarily on hold. We are testing all residents and staff for two weeks, twice a week. If no there are new cases, guidelines call for a 14 day quarantine period after which time we can resume visitations.
